It is important to note that Employment-based India 3<sup>rd</sup> Preference is not current any more. It has a cut-off date of March 1, 2002. Also, for all countries of the world, the employment based "3<sup>rd</sup> preference **other workers**" category has now a cut-off date of July 1, 2001.

Aliens in the third preference category who receive their labor certifications now with a priority date of later than March 1, 2002 will have to wait for filing their adjustment of status applications since the priority date is not current. Similarly, aliens with approved I-140 petitions under third preference whose priority date is later than March 1, 2002 will not be able to file their immigrant visa applications at U.S. Consulates abroad until their respective priority date is reached and so reported by the Visa Office in its monthly visa bulletin.

## LCAS TO BE CERTIFIED ON APRIL 1

Those desirous of obtaining H1B status are aware that the H1B cap for the current year has long been reached. In the new fiscal year beginning October 1, 2005, a fresh supply of H1B numbers will become available. For H1B petitions to be filed for jobs beginning October 1, 2005, Labor Condition Applications can be filed on April 1, 2005. As most of you are aware, LCA Certification is a prerequisite for filing petitions for H1B status. It will certainly be a run to the finish line on April 1, 2005 by those employers who are eagerly waiting to petition for their H1B candidates. Do not count on filing regular H1B petitions. File under "PREMIUM PROCESSING" paying an additional fee of \$1,000 to the Citizenship and Immigration Services for that purpose. If you file for normal processing, chances are that H1B numbers would be all used by petitioners who filed under Premium Processing and you may need to wait for another long year!
