President Advocates for H1B Cap Increase

Here are relevant excerpts from a speech President Bush gave on Feb. 2, 2006 at the 3M Corporate Headquarters:

Now, in the meantime, there's another issue that I want to discuss right quick. . . . There are more hightech jobs in America today than people available to fill them. And if that's -- so what do we do about that? And the reason it's important, and the American citizen has got to understand it's important, is if we don't do something about how to fill those high-tech jobs here, they'll go somewhere else where somebody can do the job...

And so one way to deal with this problem, and probably the most effective way, is to recognize that there's a lot of bright engineers and chemists and physicists from other lands that are either educated here. or received an education elsewhere but want to work here. And they come here under a program called H1B visas. And the problem is, is that Congress has limited the number of H1B visas that can come and apply for a job -- a H1B visa holder can apply for a job at 3M. I think it's a mistake not to encourage more really bright folks who can fill the jobs that are having trouble being filled here in America -- to limit their number. And so I call upon Congress to be realistic and reasonable and raise that cap. [Emphasis added].
