SENATE JUDICIARY COMMITTEE PASSES PROPOSAL RE H1B

About two weeks ago, on October 20, 2005, the Senate Judiciary Committee held a markup of a proposal to provide temporary relief from the H-1B visa blackout and the employment-based immigrant visa backlogs, in exchange for increased fees on some petitions. The proposal ultimately passed out of Committee by a strong 14-2 vote. Some of the provisions in the final package would:

- 1. Impose a new \$500 fee on immigrant visa petitions for the EB-1, EB-2, and EB-3 categories.
- 2. Recapture unused employment-based visas from prior years for immediate allocation of up to 90,000/year.
- 3. Exempt spouses and minor children from counting against the annual cap on employment-based immigrant visas.
- 4. Recapture approximately 300,000 unused H-1B numbers dating back to FY 1991 with a limit of 30,000 per year. This would effectively raise the cap from 65,000 to 95,000 for at least 10 years.
- 5. Impose a new fee on the recaptured H-1B visas so that the fees on the original 65,000 H-1B allotment remain unchanged but the additional 30,000 available annually carry an additional \$500 fee.

6. Impose a new \$750 fee on L-1 visas.

This proposal still must be reconciled in conference with the House's alternative budget reconciliation bill, which imposes a \$1,500 fee increase on L visas.
