# CONTINUED UNAVAILABILITY OF EMPLOYMENT-BASED VISA NUMBERS

Recent applicants of permanent labor certification under the new PERM rules have experienced mixed emotions. Those few who received labor certifications within a few months of the PERM rules taking effect are overjoyed that their labor certifications came thorough so quickly as opposed to two years or more it used to take in the pre-PERM era.

However, some have found that their joy is short-lived. With the labor certification in hand, their employers were able to file I-140 petitions for them and these employees were able to submit, concurrently with the filing of I-140, their application for adjustment of status to a lawful permanent resident. But that was when visa numbers for 3<sup>rd</sup> preference professionals were current. At present, the third preference visa numbers are unavailable for persons born anywhere in the world. So, applications for green card cannot be submitted by such applicants who have secured labor certifications so quickly.

Even when a fresh supply of visa numbers becomes available on October 1, 2005, it is not at all likely that the visa numbers in the employment based 3<sup>rd</sup> preference for India, China, and Philippines will become current.
